

Terms and Conditions for Having a Say Conference 2025



Registration Fee Types

- **'Concession'** registration rate is available to individuals who have a Health Care Card or Pensioner Concession Card.
- **'Support Staff'** – is not a registration fee, but a catering cost recovery in acknowledgement of the Companion Card. It is only available to staff, parents or carers who are attending to provide direct care and assistance (eg. transport, personal care, supervision) during the conference for individuals with disability who are unable to participate in the conference without this support.

VALID reserves the right to query unusually high staff to participant registrations, e.g. three support staff registered for two participants



- **Full rate** – is for anyone who does not hold a concession card and who is not providing direct care support as a staff person to participants with disability

What does your Registration Fee include?

Tuesday and Wednesday daytime in-person registration includes:

- All day tea / coffee
- Morning and afternoon teas each day
- Entrance to the conference expo and any sessions of their choice
- For people with a disability, entrance to one *Come & Try* activity each day.



Registration for the Disco or Dinner/Chat includes:

- Entry to the disco and the Dinner/Chat:
 - if you attend the Dinner/Chat you can walk across the foyer and join the dancing whenever you'd like, and
 - if you attend the Disco you are welcome to go across the foyer to hear the speaker in the Dinner/Chat
- A two-course meal (main and dessert)
- NOTE: that your registration fee does not include drinks, these are available at bar prices



Registration DOES NOT include:

- Single day registration for Tuesday, does NOT include registration for the dinner disco.
- Transport to and from the venue or disco
- Drinks at the disco or dinner/chat
- Accommodation (Note: please book your own accommodation)
- Meals or drinks at the optional social event HaS's Got Talent
- Please note that delegate registration fees are **GST** free.

Cancellations and Refunds

You can claim a **full refund** by emailing VALID up until 14 days before the conference. After that date there are usually no refunds, except in 'exceptional circumstances'.



If you feel you have exceptional circumstances, you can apply in writing (Email: havingasay@valid.org.au or if you are unable to email ring 0475 698 884).

Each request will be dealt with individually and if a refund is given the *catering costs* VALID *has already paid* e.g. *Dinner Disco, may be deducted.*



Group Leader and Emergency Contact

In case of emergency (e.g. someone gets separated from your group or becomes unwell in a session when they are by themselves) we need to be able to contact the Group Leader who is at the conference.



So, please provide the *Group Leader's name and mobile* please.



Attendant Care

Short-term attendant Care support is available for people who are attending the conference independently (i.e. without staff or family support).



This support is ONLY for short-term personal care and meal assistance during the conference and conference dinner.

It is important for participants to be aware that this support cannot be provided to people on a 1 to 1 basis for long periods of time during the conference.



If you are planning on attending the conference independently and have a higher need for support (i.e. require one to one attendant care support) please talk about your needs with your support network e.g. family or Support Coordinator and the services that you use.

If you are unwell

COVID-19 is still around in our community. It is well known that many people with disability can get sicker from COVID due to having other health issues already.



VALID would ask people to not attend if they:

- tested positive to COVID
- are unwell and are coughing, sneezing etc.



If you have a cold and have tested negative to COVID, we would appreciate it if you could wear a mask in crowded areas of the conference.



Come & Try (C&T) Activities



Participants with a disability who are attending:

- to do one C&T on Tuesday & one on Wednesday
- to choose an open activity to do on Thursday
- Come & Try Bookings close on the **17th January 2025**
